

# MARKETPLACE VIP REWARDS PROGRAM MEMBERS DRAW - TERMS & CONDITIONS

(as at 30 January 2019 - Authorised under NSW Permit LTPS/19/31327)

1. To be eligible to participate in the MarketPlace VIP Rewards Program Members Draw, you must be a registered member of the program.
2. All Terms and Conditions of the MarketPlace VIP Rewards Program also pertain to the Members Draw.
3. The weekly prize will be a MarketPlace Raymond Terrace Gift Voucher to the value of \$100.
4. Standard Terms and Conditions of use of the MarketPlace Raymond Terrace Gift Voucher also relate to this program.
5. The first of the Members draw will take place on Thursday 7th March 2019 and the final draw in this competition will be on Thursday 14th November 2019.
6. The Members draw will be suspended on Thursday 18th April and Thursday 25th April 2019.
7. On Thursday 27th June 2019, after the initial draw, if the Jackpot amount is over \$1000 there will be a continuous draw (every 15 minutes) until the prize is claimed by an eligible VIP Rewards Member or the time reaches the scheduled closing time of the Centre. In which case the draw resumes as normal the following week.
8. The draw will take place each Thursday between and including those dates nominated at Item 5 above commencing at 6.30pm, excluding Thursday 18th April and Thursday 25th April 2019.
9. Management reserves the right to locate the draw to any location within MarketPlace without notice or reference to any other person.
10. Members must present their MarketPlace VIP Rewards Card to receive the prize. Photo ID must also be presented to claim any VIP Members Draw Jackpot amount.
11. The following are not eligible in participating in the VIP Members Draw:
  - Centre Management Staff
  - Cleaning Contractor Staff
  - Security Contractor Staff
  - MarketPlace Retailers and their Employees (Including Casual Tenants)
12. The draw will be undertaken by a member of Centre Management or their nominated agent.
13. All numbers drawn will be via a random computer generated software program.
14. The winning member number will be announced at the draw and also via the Centre Public Address system. Results will be published on **[www.marketplacerraymondterrace.com.au](http://www.marketplacerraymondterrace.com.au)** within 48 hours of the draw.
15. If the member does not present themselves within 15 minutes of the draw being announced, then the prize will jackpot to the following draw.
16. Management reserves the right to increase the Jackpot amount at any time.
17. Once the Jackpot reaches \$1,000, and each week thereafter, there will be a total of five (5) draws each week. That is, after the initial draw and a period of 15 minutes for the member to present themselves there will be a maximum of a further four (4) draws. Each number will be called three (3) times and if the member does not present themselves by the time the next number is drawn then any previous number drawn is null and void.
18. If the Jackpot is won and reverts to \$100 then Clause 15 becomes the relevant clause.

If, as at the final date of the competition (being Thursday 14th November 2019) the jackpot has not been claimed then there will be a continuous draw after the initial draw (and 15 minutes) until the prize is claimed by an eligible VIP Rewards Member or the time reaches the scheduled closing time for the Centre. In which case the Jackpot will be deemed void and there will be no further draws in the competition.
